Competitors should be ready to play on other days at times and dates as instructed by the Referee. Competitors absent when called upon to play may be scratched.

To avoid congestion, Finals of Events 11 & 12 will commence 2pm onwards Friday 16th April. Finals of all other events, including plate matches, will commence 9am onwards Saturday 17th April.

4. Events 1 and 2 are open to players born 1989 or later.
Events 3 and 4 are open to players born 1992 or later.
Events 5 and 6 are open to players born 1994 or later.
Events 7 and 8 are open to players born 1996 or later.
Events 9 and 10 are open to players born 1998 or later.
Events 11 and 12 are open to players born 2000 or later.

PLAYERS MAY ENTER TWO EVENTS

21/U, 16/U, 12/U Events commence Monday 12th April. 18/U, 14/U Events commence Tuesday 13th April. To ensure smooth running of the Tournament, exceptions will not be allowed.

Prizes will be presented for each event.

5. Entries should be made on the form accompanying this Prospectus and must be delivered on or before Monday 22nd March 2010, to the Hon. Tournament Secretary and must be accompanied by the appropriate fee, made payable to WHITEHALL L.T.C.

A first class stamped & addressed envelope must be enclosed for your first match notification.

Any player withdrawing from the Tournament after the closing date for entries, must notify the Hon. Tournament Secretary in writing as all withdrawals have to be reported to the LTA.

6. Events 1 to 10 shall be the best of three sets with a tie-break being played at six games all, in all sets. Finals on Saturday 17th April.
Events 11 & 12 Round Robin, to be played on Thursday 15th April in the morning starting at 9am, thereafter quarter finals in the afternoon. Semi-finals and final on Friday 16th April.
7. Competitors should inform the Referee before leaving the ground at any time. Any player not available for play within 30 minutes of being called may be scratched
8. Recognised tennis clothing and non-marking rubber soled tennis shoes must be worn. In early Spring court surfaces may be wet, competitors are advised to wear shoes that are suitable for playing on porous Macadam courts in the prevailing weather conditions.
9. Complaints in connection with the Tournament must be made in writing and will be dealt with according to LTA Tournament Regulations 3.10 Complaints.
10. The following persons shall be ineligible to serve on the Committee of, or manage or compete in the Tournament:
 - (a) Persons whose rights to compete have been suspended by the Council of the LTA - any Tournament.
11. Competitors must report to the Referee's table on arrival each day. Competitors who are absent when called upon to play are liable to be scratched at the discretion of the Referee.
12. **Powers of the Committee and Referee:** Any competitor guilty of bad court behaviour - such as swearing on court, racquet throwing, displays of violent temper, unsportsmanlike actions, bringing the game into disrepute, may be suspended or disqualified by the Referee and Tournament Committee (LTA Code of Conduct applies). Their decision shall be final.
13. The Committee reserve the right to alter or modify the programme and conditions in any way they think fit, subject to compliance with the Rules and Regulations of the LTA.
14. Competitors may request an Umpire to be provided, prior to or during the course of a match. Competitors are expected to umpire when requested to do so.
15. Refreshments will be available throughout the Tournament.
16. Competitors and Parents/Guardians will become temporary members of the Club for the week, but the Club cannot accept any liability for the loss of personal property and recommends that in your own interests you should insure your property.
17. In all matters appertaining to the conduct of the competition, the Referee's decision will be final.
18. Sponsorship of the Tournament is by the "WILSON SPORTING GOODS COMPANY LIMITED". ITF approved "WILSON" tennis balls will be used throughout the Tournament.
19. An LTA National Ratings Card must be produced when signing in at the Tournament.
